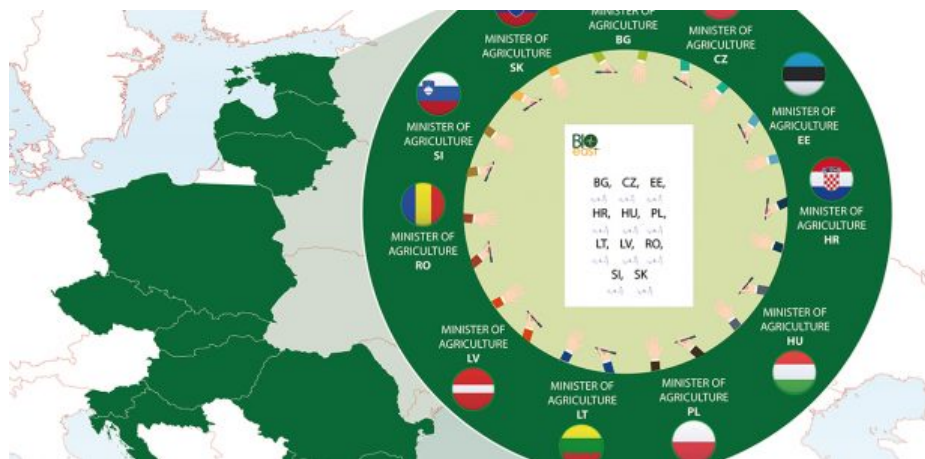


## ABOUT US

BIOEASTsUP is a project funded through the European Research and Innovation programme, Horizon 2020, and will last for the duration of three years (October 2019 to September 2022). It is a coordination and support action in response to the Call RUR-18-2019, "Support to the BIOEAST initiative: boosting knowledge and innovation-based bioeconomies". The Central-Eastern European Initiative for Knowledge-based Agriculture, Aquaculture and Forestry in the Bioeconomy – BIOEAST – offers a shared strategic research and innovation framework, which aims at working towards sustainable bioeconomies in the Central and Eastern European (CEE) countries. The project consortium consists of 21 partners from 14 countries and aims to support the BIOEAST initiative and Action Plan for the transition of 11 Central and Eastern European (CEE) countries to the bioeconomy.

### National platforms for bioeconomy strategy development

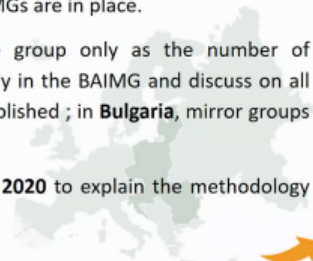


The main driving force of the national platforms for bioeconomy development are the **inter-ministerial groups** (BAIMG) and the **national stakeholder** (NSG).

In eight countries (HR, CZ, EE, HU, LV, SI, PL and RO) BAIMGs are in place.

**different approaches:** in **Estonia** there will be one group only as the number of stakeholders is limited and they can be involved directly in the BAIMG and discuss on all topics; in the **Czech Republic**, a BIO Hub has been established; in **Bulgaria**, mirror groups to the BIOEAST TWGs have been created.

BIOEAEAST **webinar series** were organised on **May 28, 2020** to explain the methodology and functions of the national platforms.

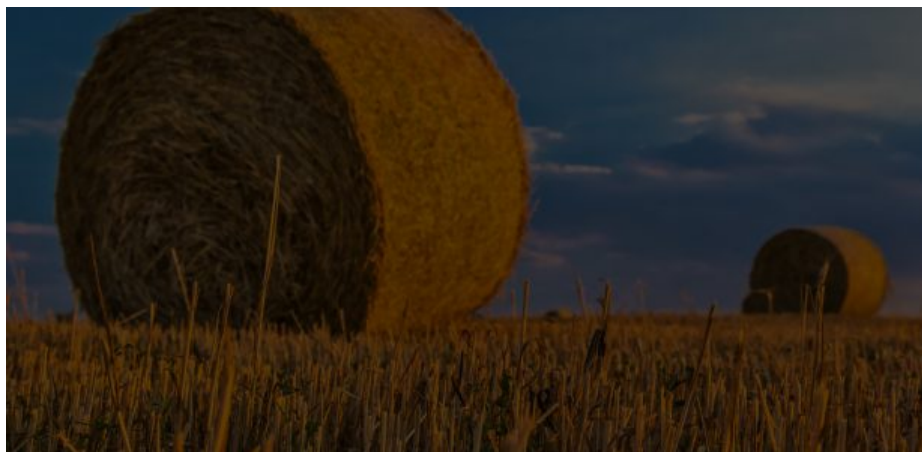


## H2020 GREEN DEAL CALL – SUMMARY OF THE VIRTUAL BROKERAGE EVENT

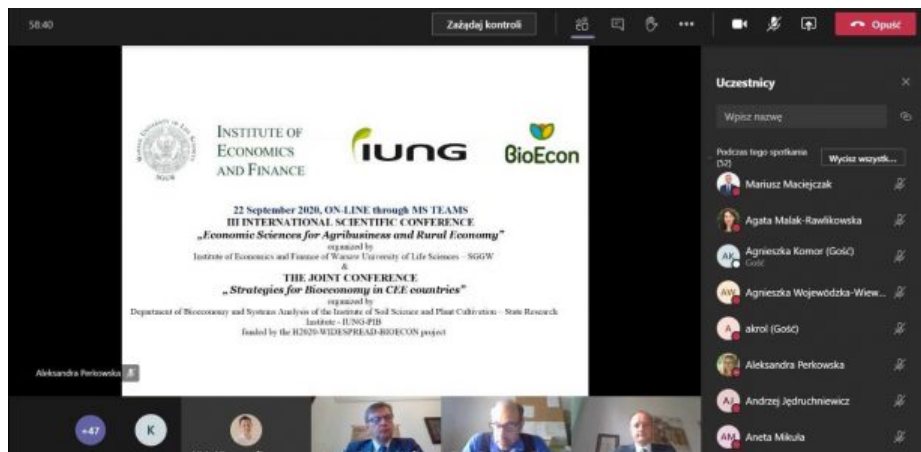

Barna Kovács had the honour to participate at the EU R&I Days as panelist in the Green Deal session on 22 September 2020. The discussion was about the role of bioeconomy in the EU post-COVID recovery of the European Union and its Member States in light of the EU Green Deal. The European Commission's proposed recovery instrument Next Generation EU, with a strong budget of €750 billion, will support EU Member States in their efforts to recover, repair and emerge stronger from the crisis, while accelerating the green transition.
